This is a summary of drug and health services covered by Senior Care (HMO I-SNP) from January 1 – December 31, 2026.

Senior Care (HMO I-SNP) is a Medicare Advantage HMO plan with a Medicare contract. Enrollment in the plan depends on the plan's contract renewal with Medicare.

To join Senior Care (HMO I-SNP), you must:

- Have both Medicare Part A and Medicare Part B,
- -- *and* -- live in our geographic service area,
- -- *and* -- be a United States citizen or be lawfully present in the United States,
- -- *and* -- meet the special eligibility requirements: Our plan is designed to meet the specialized needs of people who need a level of care that is usually provided in a nursing home. To be eligible for our plan, you must reside in one of our participating nursing facilities for greater than 90 days OR live in a community setting (including in an assisted

living or independent living community) and meet the institutional level of care. The plan's *Provider Directory* has a list of participating nursing facilities. You can access this list on our website at AlignSeniorCare.com or call Member Services and ask us to send you a list.

Our service area includes these counties in Florida: Alachua, Broward, Dade, Hillsborough, Lee, Orange, Osceola, Palm Beach, Pasco, Pinellas, Seminole, and Sumter.

Senior Care (HMO I-SNP) has a network of doctors, hospitals, pharmacies, and other providers that can be found on our website at AlignSeniorCare.com. If you use providers that are not in our network, the plan may not pay for these services.
